APPLICATION FOR PERSONS WISHING TO REPRESENT STAKEHOLDERS IN THE BOARD OF DIRECTORS OF WAJIR WATER AND SEWERAGE COMPANY LTD.

Wajir Water and Sewerage Company (WAJWASCO) is a Water Service Provider that has been mandated to provide water and sewerage services in Wajir County and is fully owned by Wajir County Government.

The Board of Directors comprises representatives of stakeholders identified by County Government of Wajir, Northern Water Services Board, and the Water Company in accordance with Corporate Governance Guidelines issued by the Water Services Regulatory Board.

The Board of the Company has vacancies for **representatives** of the following stakeholders:

- i. Two (2) No. Members Representing business and manufacturing community.
- ii. One (1) No. Member representing local professionals
- iii. One (1) Member representing resident organizations including faith based organizations.
- iv. One (1) No. Member representing Users/Consumers.
- v. One (1) No. Member representing Women Organizations.
- vi. One (1) No. Member representing local NGO's

This is therefore to invite applications from nominees of the above stakeholders.

The applicants should enclose a letter of nomination/Recommendation from their respective stakeholder organization/institution together with their own applications and copies of credentials and certificates.

The stakeholder organization/institution is advised to recommend more than three applicants to allow for a competitive evaluation of applications.

The applicants must meet the following **criteria**:

- i. Be literate and numerate to at least O' level.
- ii. Demonstrated experience and acumen in business or any profession for at least 7 years.
- iii. Demonstrated participation in local development initiatives.
- iv. Has experience as a change management agent.
- v. Be a resident of the area served by the company.
- vi. Must meet the requirements of Chapter 6 of the constitution of Kenya 2010 by attaching the application with **copies** of:
 - a. Clearance certificate from Ethics and Anti-Corruption Commission(EACC)
 - b. Certificate of good conduct from the Criminal Investigation Department(CID)
 - c. Clearance certificate from Higher Education Loans Board(HELB)
 - d. Certificate of Compliance from Kenya Revenue Authority(KRA)
