PUBLIC NOTICE

APPLICATION FOR STAKEHOLDERS WISHING TO BE REPRESENTED IN THE BOARD OF DIRECTORS OF WAJIR WATER AND SEWERAGE COMPANY (WAJWASCO), AN AGENT OF WAJIR COUNTY GOVERNMENT.

Reference is made to the 4th Schedule Part 2(11b) of the Constitution of Kenya and the Gazette Notice No. 174 dated 9th August, 2013 for the transfer of Water and Sanitation services to the county Governments.

The Corporate Governance guidelines issued by Water Services Regulatory Board (**WASREB**) requires that the Board of Directors of Water Service Providers (WSPs) shall comprise of nominees of stakeholders served by the Water Service Provider. The process of appointment of Directors therefore shall be as follows: -

1. Wajir County Government and Northern Water Service Board shall have a list of all stakeholders in the concerned service area.
2. Wajir County Government and Northern Water Service Board shall advertise in the local media positions of Directors for **WAJWASCO** and shall set the criteria for those eligible to apply in accordance with the guidelines.
3. Wajir County Government and Northern Water Service Board shall call a stakeholder conference in the service area to create a selection committee of five members from the stakeholders who will evaluate the applications submitted after the advert for the positions of BOD.
4. A date shall be set by Wajir County Government and Northern Water Service Board for the applicants to be interviewed by the stakeholder selection committee.
5. The stakeholder selection committee shall select and forward the names to the Wajir County Government and Northern Water Service Board according to the eligibility set in the guidelines.

6. The Wajir County Government and Northern Water Service Board shall notify the names to the shareholders for ratification.
7. The selected Directors shall then meet the Wajir County Government and Northern Water Service Board where they are to be inducted in a Corporate Governance Workshop and they sign the Code of Ethics before commencing business.
8. The Wajir County Government and Northern Water Service Board shall communicate the directors' list and background to **WASREB**.

The County Government of Wajir in collaboration with Northern Water Services Board therefore calls for applications from **Stakeholders** wishing to be considered in nominating a representative to the Board of **Wajir Water and Sewerage Company Ltd**. The applicants (Stakeholders) must provide the following: -

- i. Registration certificate.
- ii. A letter of intent of not more than 2 standard A4 pages indicating the stake they hold in the management of water services in Wajir County and its environs, the experience and skills its representatives will bring to the Board, and the interest group they represent.
- iii. A confirmation that it will, if required to do so, recall any of its representatives who is later found to have misconducted himself or herself in the performance of their duties in the Board.

The Expression of interest should be in a sealed envelope marked. “**APPLICATION OF STAKEHOLDERS FOR WAJIR WATER COMPANY**” And be posted to the address given below. The deadline for submission of the expression of interest is 15th September, 2018.
