(b) On completion of his/her studies as provided in the scholarship rejoin or enter in the Wajir County Government work force for a period of Three (3) years.

Provided that the Governor shall have power to release him/her from such obligation at any time before the expiration of the said period or as he/ she shall in his or her sole discretion think fit.

THE SCHEDULE BELOW REFERS TO RULES GOVERNING THE AWARD OF SCHOLARSHIPS MADE BY  
WAJIR COUNTY GOVERNMENT.

Every person awarded a scholarship by the WAJIR COUNTY GOVERNMENT is required to Comply with the  
following rules:-

- a) To devote his/her time to following the course of instruction for which the scholarship is awarded unless  
permission to undertake other, work or studies or, to modify his/her course in content or duration is granted by  
Wajir County Government.
- b) To satisfy the WAJIR COUNTY GOVERNMENT as to attendance, conduct and progress by report from the  
head of the institution or such other approved person at the institution in which he/she is studying.
- c) At all times to conduct himself/herself as an honest and faithful student and to the best of his/her power and  
ability faithfully to observe, obey and perform such instructions may take.
- d) To complete the course without interruption and to fulfill all the conditions under which the scholarship was  
awarded.

(2) The scholarship may be suspended or terminated if the person awarded a scholarship fail comply with any of the  
foregoing rules.

(3) All beneficiaries will be required to sign the following declaration in the presence of a WAJIR COUNTY  
GOVERNMENT lawyer or an officer duly authorized in that behalf by WAJIR COUNTY GOVERNMENT.
